Eric gave maintenance report, motor at the sewer plant removed. We will replace after completing other projects. Also discussed 5165 Blackmon Drive, meter was removed due to non-pay, Eric explained we did not charge for meter installation. Owens suggested in future to charge for the replacement of meter due to non-payment on a property address. Maintenance guys changed out a gas meter on Hwy 89. Zack to finish installation upon return to work.

Wayne Godwin discussed Jay Church of Christ gas bill.

Automated water meter latitude and longitude locations should be updated this week.

Eric also talked about the meters being offered by Pace Water System for half price. Town of Jay system needs 163 water meters, 75 gas meters to be installed. Time keeping equipment, tabled to next meeting.

Bush discussed naming Community Center after Linda Carden, a 40-year employee.

Owens stated that council needs a contract from Attorney Steve Cozart. Office did advertise for engineer in newspaper.

Eric to talk to Theresa Dobson regarding banners.

Discussion regarding Raymond McDaniel part time hours being 25 a week.
