Councilwoman Hayes made a motion to complete change order #001 for said bid to move the parameters to within the scope of the project provided by CDBG of \$541,000.00. Seconded by Councilman Holloway. 3 yeas, 0 nays. Motion carried.

**Town of Jay Logo:** Mr. Seib spoke with an area graphic artist about a new logo for the town. The cost presented by this artist was \$2,000. Discussion followed. The council would like to get other quotes before making a decision.
